Award Nomination Information

The ULBC Board of Directors is seeking nominations of individuals and organizations that continue to show business excellence and commitment to minority business development in the following categories:

- A. Individual Advocate of the Year** This individual has advocated for and on the behalf of Latino and minority-owned businesses, and continues his/her efforts to help them realize more opportunities for business growth.
- B. Corporation of the Year** This organization is a for-profit business that is actively working with the Latino and minority-owned business community to build relationships and create profitable business opportunities for each of the parties involved.
- C. Service Provider of the Year** This individual or organization is a recognized for its innovative service offerings, efforts, niche and leadership in the minority-owned business community. The nominee is a contributor towards economic development initiatives involving the minority business development.
- D. Small Business of the Year** This nominee has demonstrated success as a business owner while continuing to advocate for and provide opportunities to other Latino and minority-owned businesses.
- E. Government Advocate of the Year** This individual or government agency is recognized for outstanding contributions and commitment to the advancement of Latino and minority-owned businesses. This nominee has gone beyond the normal responsibilities associated with his/her position or agency and has become actively involved in making a positive difference by providing opportunities and facilitating business solutions.
- F. Legacy Award** This is awarded to a company/corporation/organization for a lifetime of special efforts towards minority businesses by being involved in the community and helping Latino and minority-owned businesses socially and/or civically. (It is not intended as recognition for accomplishments associated with activities related to a specific person.)

Nomination Process:

- Complete the attached form for each category you wish to nominate an individual or organization. The ULBC is interested in candidates who are excelling in business and advocacy; they need not be a ULBC member to receive recognition.
